We may reject any item or service not meeting this warranty and require correction and replacement, without cost to us. Should you fail to comply with this warranty, you will indemnify, defend and save us harmless from and against all suits, claims, demands and expenses in connection with the work done under this order and in any way growing out of any accident resulting from any and all items

furnished to us under this order.

**QUALITY** Material is subject to buyer's inspection and approval at a reasonable time after delivery. If specifications are

not met, material may be returned at seller's expense.

DISCOUNT Calculated from the date acceptable invoice is received by this buyer. Invoices lacking terms will be discounted

2% - 10-day basis.

**TAXES** The seller agrees to pay any taxes imposed by law upon or on account of the within material, unless otherwise

agreed.

**TOOLS** Tools of all kinds held by vendors for making our parts must be repaired, renewed and fully insured against

possible loss or damage, and are subject to removal at any time upon demand, unless otherwise agreed.

SHIPMENT Must be made within the time promised, failing which buyer reserves the right to purchase elsewhere and

charge vendor with any loss incurred, unless deferred shipment has been authorized.

**PATENTS** The seller shall hold and save the purchaser, its officers, agents, servants, and users of its products, harmless

from liability of any nature or kind, or an account of the use, sale or lease of any patented or unpatented

invention, articles or appliance furnished or used hereunder.

**PRICE** If prices are higher than specified, do not ship. Advise us. If price is omitted, it is agreed that the material shall

be billed at the price last quoted or paid, or the prevailing market price, whichever is lower.
